



# THE UTAH STATE SENATE

#### THE SENATE

The Utah State Senate is a body of 29 men and women elected to four-year terms. About half of the seats in the chamber are up for election on an alternating basis every two years. Each Senator represents a constituency of approximately 50,000 people. A senatorial district may be a portion of one county or two or more counties or a combination of both. The Senate is reapportioned as desired or as required by law to insure that each Senator represents as nearly as possible approximately the same number of constituents.







#### **GOVERNOR**

Norman H. Bangerter is serving his first term as Governor of Utah after a varied career in the State House of Representatives. A building contractor, native of Granger, Utah, and a Republican, Governor Bangerter was first elected to the House in 1974 and served as Assistant Majority Whip (1977–78), Majority Leader (1979–80) and Speaker of the 44th and 45th Legislatures (1981–84).

### **GOVERNOR**

W. Val Oveson, Republican, is in his first term as Lieutenant Governor of Utah after serving as the State Auditor in 1981–84. Lieutenant Governor Oveson is a native of Provo, Utah, currently residing in Bountiful, Utah. # THE UTAH STATE HOUSE OF REPRESENTATIVES

#### THE HOUSE

The House of Representatives is composed of 75 men and women elected to two-year terms. House seats are up for election every two years in even-numbered election years. Each representative has a constituency of approximately 20,000 people and, like the Senate, the House is reapportioned periodically. Representatives' constituencies may include a county or portion of a county or one or more counties or a combination of these.

#### **HOW LAWS ARE MADE**

Proposed laws are introduced as bills in either chamber, are reviewed by fiscal analysts, legal counsel and a rules committee. The bill goes to a standing committee for study, possible public hearing, amendment or other action. The committee may table the bill or send it back to the originating chamber with a recommendation for action. If passed by that chamber, it is sent to the other chamber for similar procedure. If passed there, the bill goes back to the chambers for final review then to the Governor for signature or veto. If signed by the Governor, the bill becomes law in 60 days, or on the date proscribed. If vetoed, the Legislature may accept the veto, or attempt to override it.
